House Rules

Quorum

1. 10% of paid up members present will constitute a quorum.¹

Motions

- 1. A motion is a formal proposal by two members, a mover, and a seconder.
- 2. The Board will ensure that the following procedural motions are made at every AGM:
 - a) Motion to Approve the Agenda
 - b) Motion to Approve Prior Year's Minutes
 - c) Motion to Approve Year End Financial Statements
 - d) Motion to Appoint the Financial Auditors
 - e) Motion to Destroy Board of Directors Election Ballots
 - f) Motion to Adjourn
- 3. All other motions, except motions to alter the bylaws, shall be in writing and delivered to the President by 5:00PM, the day preceding the AGM. Motions to alter the bylaws must be submitted in writing as per bylaw Article XIV, 60 days prior to the AGM.

Discussion & Voting

- Once a motion has been moved and seconded, the President will call for the matter to be
 discussed. Anyone who wishes to make a comment or ask a question must first be recognized by
 the President and, unless the President allows it, may not ask the same question or make the
 same comment more than once. The mover of the motion may have the last word. After the
 discussion, the motion may be amended if both the mover and seconder agree.
- 2. After a motion has been discussed, the President will call for a vote. Those eligible to vote will vote either for or against the motion. 50% plus 1 of the votes cast must be in favour of the motion for it to pass.

2020 NWTRPA Virtual Annual General Meeting Minutes November 26, 2020 GoToMeeting

7. President's Report

Cynthia White presented the President's Report:

The NWT Recreation & Parks Association had a strong year in 2019-2020 that ended on March 31 just as lockdown was in full swing. I would like to share with you some of the highlights from the last fiscal year. Please see a copy of our annual report for more detailed information.

The NWT Recreation & Parks Association promotes recreation by supporting leaders, communities, and partners through training, advocacy, and networking. We envision a territory where everyone has the access to recreation programs and spaces that foster healthy families, strong cultures, and vibrant communities.

The NWTRPA 2018 - 2021 Strategic Goals are to:

1. Advance decolonization and reconciliation

- 2. Be a valued organization
- 3. Advance the understanding of recreation
- 4. Be a vital resource for on the land programs
- 5. Advance active ways of living
- 6. Be the leading recreation training organization

The annual report that you have been given, describes in more detail the work that has been done to advance each goal.

I think that most of you will be familiar with some of our key initiatives. Let me highlight a few of them:

- Recreation North is a 2015 Arctic Inspiration Prize-winning training program for northern recreation leaders. This program is a joint venture with the Nunavut and Yukon Parks and Recreation Associations.
- **HIGH FIVE** is a national program that provides training to recreation leaders working with children aged 6 to 12.
- Walk to Tuk is an annual walking challenge that brings together teams to conceptually
 walk the length of the Dehcho in January and February. In 2020, nearly 4,500 people took
 part in Walk to Tuk.
- Get Active is a funding program that support community-based active living events.
- **Elders in Motion** provides training and support for communities, groups, and individuals interested in developing and maintaining an elder recreation program.
- **Generations on the Move** is supports and promotes programs that create intergenerational connections.
- On the Land Programs provides training and program support to community on the land programs. We are a key member of the NWT On the Land Collaborative by providing administrative support to the Collaborative and in-kind support to Collaborative-funded projects.
- And the NWTRPA Conference is an educational event for recreation professionals, educators, Elders, health care workers, youth centre workers, and volunteers from across the NWT and is an opportunity to celebrate recreation leaders and programs at our annual awards banquet being hosted this evening.

I would like to point out a few highlights from last year. You can also read about these starting on Page 8 of the annual report:

- Recreation for Mental Health was offered as a pilot training.
- We worked with Recreation Nova Scotia who developed the training with Dalhousie
 University and the Canadian Mental Health Association. The goal of this initiative was to
 "work together across recreation and mental health sectors to support the inclusion of
 people living with mental health challenges in the recreation life of their community."²
- With support from the Department of Health and Social Services, 21 participants from various backgrounds from across the NWT participated in the 4-hour training hosted in Behchokò.

- Feedback was collected from all participants as well as from a small group who gathered the following day for a debrief.
- We are working towards next steps on being able to offer a version of this training more regularly in the NWT.
- **Tłįcho Camp Yoga** was developed by staff at the Jimi Erasmus Qhdaa K'ehodil Ko (Jimmy Erasmus Seniors Home) in Behchoko. The program, which is taught in Tłįcho, is a fun, engageing, and culturally relevant, community-developed, form of exercise for people of all ages.
- The NWTRPA worked with staff at the Jimmy Erasmus Seniors Home, the Tłįcho
 Community Services Agency and Adze Studios to create 3 videos that link the Tłįcho
 language with a series of actions mimicking land-based activities like checking nets and
 chopping wood.
- Elders living in Behchokò, Gamètì, Wekweètì, Whatì, Yellowknife, and beyond now have access to the physical and mental health benefits of Tłycho Camp Yoga.
- All three of the videos are posted on the nwtrpa.org website and on our YouTube channel.
 The videos are all about 6-7 minutes long.
- Indigenous-Focused Trauma Informed Training for On The Land Leaders was offered in 2019. Participants learned about using culture and traditions as an intervention for fostering mental wellness; basic facilitation skills in a camp setting; and understanding ourselves to foster healthy interpersonal relationships.
- Dehcho First Nations, the NWTRPA, and two Indigenous mental health professionals collaborated to deliver a training.
- Nineteen on the land leaders from across the Dehcho region and Sòmba K'è (Yellowknife) gathered for three days of Indigenous focused trauma-informed practice training in Łiídl

 Kýé.
- As a result of this training, we continue to work on developing a mental health training
 program specifically for on the land leaders. We established a steering committee for
 Supporting Wellbeing, an emerging training program to enhance the capacity of land-based
 programmers to manage and respond to mental health challenges on the land.

For 2020-2021 and beyond, the NWTRPA will continue to work on our strategic priorities.

- Given the uncertainty of the current pandemic, we are continuously adapting, reviewing, and enhancing our work while prioritizing safety. We plan to continue to support recreation and recreation leaders no matter what the future brings.
- The NWTRPA wants to ensure our Board of Directors and is representative of our membership and continues to be engaged in the development of our programs and policies. This year, we will continue to review our Board positions, and the nominations and elections processes to improve Board representation.
- The NWTRPA also want to ensure racial equity within the organization. We will continue to explore ways to assess the readiness of the organization to take on racial equity work.
- The NWTRPA will work on creating an action plan that reduces our environmental impacts and showcases our commitment to addressing climate change.

- Advocacy priorities will be informed by our strategic goal centered on working with intention to advance decolonization and reconciliation through our work, workplaces, and relationships.
- And finally, we will be working to advance recreation programs with the territorial government and working with the Canadian Parks & Recreation Association to advance recreation with the federal government.

In closing, I would like to thank my colleagues on the Board who volunteer their time, energy, and experience to lead our organization. I would also like to thank our staff who make the NWTRPA one of the best non-profit organizations in the NWT. And finally, I would like to thank all of our members for your support and contributions to the organization over the past year. Mahsi cho.

Sheena Tremblay presented the 2019-2020 Financial Statements and Report. Detailed audited financial statements are provided on pages 14-15 of the annual report. These statements were produced by Crowe MacKay LLP; they did not find any irregularities in our finances. These were recently reviewed and approved by the NWTRPA Board of Directors.

- The increase in tangible capital assets is because of the Walk to Tuk website. This is because of its proprietary nature of the code that was developed. It has potential to generate revenue.
- The 2019/2020 fiscal year only saw a slight impact of COVID-19 on operations as there was about three weeks of no programming.
- The NWTRPA has concluded another successful year and its financial position remains strong.
- The NWTRPA continues to build partnerships to better deliver programs and services for our members. We are looking towards another good year, both financially and with the programs and services that we offer our membership.
